

Minnesota District Office

In fiscal year 2023, the U.S. Small Business Administration (SBA) Minnesota District Office (MNDO) team and partners worked tirelessly to help small businesses recover, start, and scale. We want to thank our lending and resource partners for going the extra mile to ensure the success of our small businesses, and the communities they support. The quick actions and willingness to help from our partners across the state ensured that small businesses continued to bring economic impact and vibrancy to cities and towns in all regions of Minnesota.

Overall, the total dollar amount of SBA backed lending continued to be quite strong in fiscal year 2023 (as compared to pre-pandemic historical levels) with over \$799 million of SBA backed capital obtained by Minnesota Small Businesses. Of note, in FY23 we saw an increase in the number of SBA loans to minority populations by 12% compared to the year prior following large gains since 2020. As a direct result of SBA guaranteed 7(a) and 504 small business financing, over 18,400 jobs across Minnesota were created or saved. These loans were made through banks, credit unions, CDFIs, and CDCs.

"SBA programs remain at the forefront for businesses seeking to start, grow, expand, and recover," shared SBA Minnesota District Director, Brian McDonald. "Small businesses are the backbone of the American economy, and our partners and lending community play a critical role in the small business ecosystem. Through SBA's guaranteed loan programs, trusted counselors & mentors, and field support - SBA is helping small businesses succeed every day."

FY23 LENDING ACTIVITY

Powering the American Dream

Total Minnesota SBA lending reached \$799 million in FY23.

7(a) Loans

\$614 million

1,563 7(a) loans were approved in FY23, which helped Minnesota's small businesses start, grow, and expand. In FY23 the SBA 7(a) program increased the number of Minority-Owned (Black, Hispanic/Latino, AANHPI, and Native American) loans by 12%.

504 Loans

\$182 million

217 loans supported small businesses in commercial real estate and large mechanical equipment expansion in Minnesota.

Microloans

\$3.4 million

There are 9 SBA Microloan Intermediaries in Minnesota. This year, **189** microloans were approved assisting Minnesota small business owners with access to small amounts of capital.

Additional Small Business Assistance

SBIR/STTR Highlights

The Small Business Innovation Research/Small Business Technology Transfer (SBIR/STTR) program funds technology-focused small businesses with qualifying federal grants and contracts for research and development or prototyping operations from participating federal agencies.

SBIR/STTR programs provided 42 grants for \$37,406,824 and 25 contracts for \$16,445,730 in Minnesota in FY23.

Surety Bond Highlights

Surety bonds help small businesses win contracts by providing the customer a guarantee that the work will be completed. Many contracts require surety bonds, which are offered by surety companies. The SBA guarantees surety bonds for certain surety companies, which allows the companies to offer surety bonds to small businesses that might not meet the criteria for other sureties.

SBA guaranteed 85 Surety Bonds for \$63 million in Minnesota in FY23.
